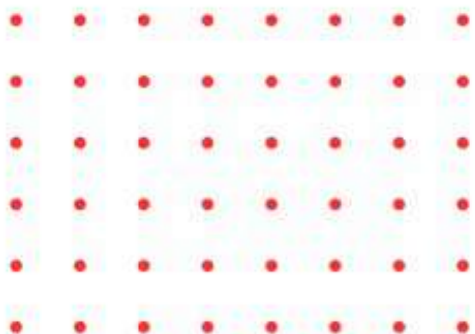




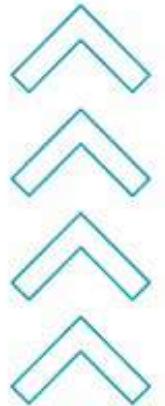

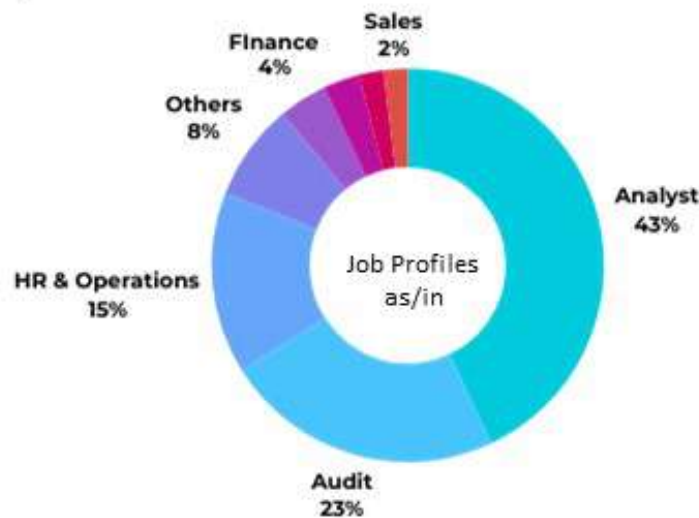

1. Admissions will start after declaration of 12th standard results.
2. All details regarding admissions will be notified on the college website.
3. Students have 7 subjects in the first year of UG out of which 3 subjects are compulsory (Compulsory English, Additional English and Economics).
4. The next two subjects are Major Elective 1 and Major Elective 2. Elective 1 will be considered as his/her major paper and Elective 2 as his/her minor paper in the Second Year. ([Major Electives](#))
5. The sixth paper is on Indian Knowledge System (IKS) and the student can choose one out of many alternatives.
6. The last paper is an option between Mathematics and Business Computing.



## Instructions for Admission in First Year B.A (UG)

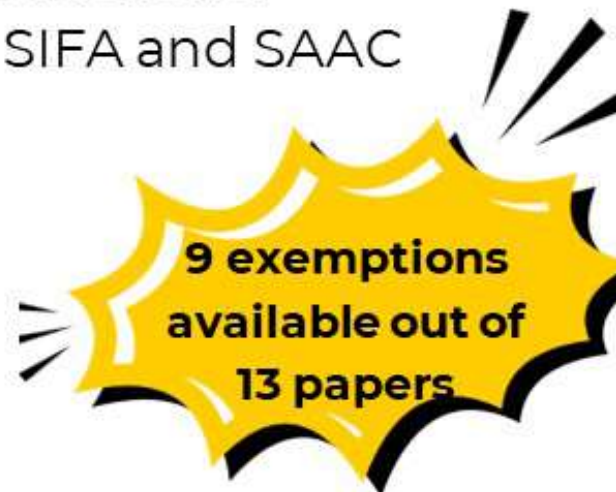
1. Admissions will start after declaration of 12th standard results.
2. All details regarding admissions will be notified on the college website.
3. Students have 7 subjects in the first year of UG out of which 3 subjects are compulsory (Compulsory English, Geography, Political Science).
4. The next two subjects are Major Elective 1 and Major Elective 2. Elective 1 will be considered as his/her major paper and Elective 2 as his/her minor paper in the Second Year. (Major Electives)
5. The student will also have to a paper on Indian Knowledge System (IKS) and can choose one out of many alternatives.
6. The last paper will be an option between Hindi and French.
- 7. Once the student selects Psychology as Major Elective 1 he/she cannot opt for this subject as a minor.**
- 8. Those students opting for English/Economics as Major Elective 1 can choose Psychology as a Minor.**

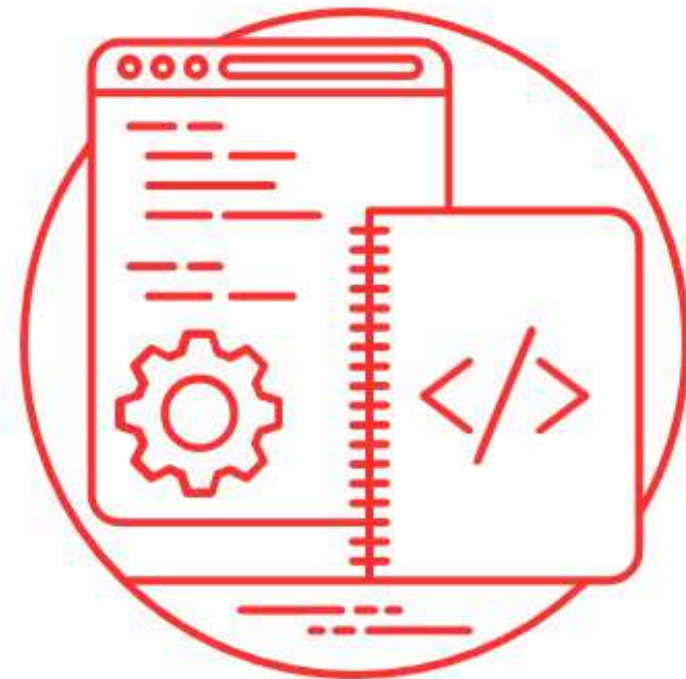
