The virtual meeting started at 10.05 a.m. with a welcome by Dr. Yogini Chiplunkar, Head Department of Business Administration. She also introduced the new BOS members and mentioned that the syllabus for FY, SY and TY were approved by the previous BOS members and also that BOS members are changed every 3 years.

- Dr. Shubhada Tamhankar introduced the department of commerce to all the BOS members and requested Dr. Soman to formally welcome the BOS members for this academic year.
- Principal, Dr. Hrishikesh Soman expressed his views on the futuristic and robust syllabus and mentioned that the syllabus should be such that students become employable by the end of their undergraduate and postgraduate degree. With special mention about multiple entry and exit systems and Academic Bank of credit, sir welcomed suggestions on relevant syllabus that would challenge the status quo.
- Dr. Yogini Chiplunkar, briefed about the agenda of the meeting. She mentioned that
 the minutes of the previous meeting were sent to members by email. These minutes
 were approved by all the members.
- Dy. Yogini Chiplunkar also elaborated on the need of linking COs, PSOs and POs.
 The COs and PSOs were sent to the member by email. Dr. Rama Venkatachalam appreciated the COs and said that the change from the previous course objectives was evident and that the COs were well formulated. The COs and PSOs were then approved by all the members.
- Dr. Sharayu Bhakare and Dr. Shubhada Tamhankar also proposed a change to special paper 7 for TY B.com of Entrepreneurship specialisation. Since there is a similar subject at the FY level, Ma'am proposed to change the name from Dimensions of Business to Dimension of Entreprise, which was approved by the board.
- Dr. Ravi Kumar Sir wanted to know if the HR papers included labour laws and Ms.
 Tejaswini Shewate explained that TY students learn a full course covering labour laws. He also suggested including HR analytics in the syllabi. Dr. Hrishikesh Soman further added to this saying we would be adding Data Analytics for B.Com, M.Com and M.A. Economics courses in the years to come.
- Dr. Varsha Nerlekar Ma'am suggested that Machine Learning and Designing
 Thinking would be a good addition to the syllabi of commerce to which, Dr. Sharayu
 Bhakare said that Entrepreneurship has a subject on Design Thinking.
- Ms. Sapna Karia suggested that a little of CRM should be included in the Dimensions of Enterprise and Dr. Sharayu Bhakare agreed to take that into consideration.

- Mrs. Sarika Wagh and Dr. Zakira Shaikh, briefed the board about the new M.Com structure in details including the credits, subjects and teaching pedagogy. The board made a few suggestions on the same (see attached list of suggestions for M.Com)
- All the M.Com teachers presented the syllabus they drafted and welcomed suggestions from the board. (see attached list of subjects and teacher who presented the subjects).
- One after the other, the board members made some exploratory suggestions to the new M.Com subjects which were taken into consideration by the respective teachers.
- Dr. Soman invited members to comment on the overall impression of the members on the new M.Com structure. Dr. Ravi Kumar congratulated Dr. Soman and all the M.Com teachers for drafting very relevant and market driven M.Com courses. Dr. Rama Venkatachalam expressed her wish to join the M.Com course on a lighter note. Mr. Rohit Lalwani, Dr Varsha Nerlekar and Ms Sapana Karia also congratulated Soman sir and all teachers for contemporary new M.Com courses.
- Dr. Soman thanked all the members for their valuable suggestions and invited all the members on campus once the pandemic situation eases out.
- Dr. Yogini Chiplunkar expressed her gratitude on behalf of the Commerce
 Department and requested Dr. Shubhada Tamhankar to propose a Vote of Thanks.
