

Centre for the Study of Society

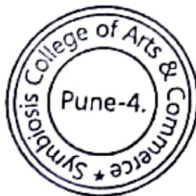

Guidelines for Minor Research Projects and Projects under Centre for Study of Society (CSS)

• INTRODUCTION & OBJECTIVES

The college aims to provide financial support to meet the research requirements for individual and excellent research in specialized areas

• ELIGIBILITY/TARGET GROUP:

1. The college will provide financial assistance to Full-time faculty appointed on permanent and regular basis on government scale and full-time Ad- hoc faculty appointed under society scale, who wish to undertake, along with teaching work, a Minor/CSS Research Projects.
2. A faculty can avail only one project/ scheme at any given time. The one, which is offered and accepted first must be completed before the other offer is accepted. Failure to abide by this rule shall make the Principal Investigator liable to refund the entire amount paid by the college
3. It would be the responsibility of the Principal Investigator for total accountability of the project
4. The Principal Investigator should publish two papers (in case of MRP) and one paper (in case of CSS project) in a reputed UGC approved journal or in the form of Chapter in a Book/ Books etc. on the basis of the said project before the final submission of the project.

• CENTRE FOR STUDY OF SOCIETY (CSS) - An initiative under College with Potential for Excellence)

- The Centre for the Study of Society has been established with the intention to understand the societal concerns and challenges and in order to provide comprehensive policy measures to resolve these issues.
- The Centre aims at undertaking thematic research which would sensitize individuals on varied issues and concerns of the society. The intention is also to generate Scholarly work in shaping public policy.
- Teachers are requested to identify the issues for research and to undertake short term projects either individually, or can be co-authored with another one or two teacher. The project can be in collaboration with other institutes.
- Short Term Projects: The project can range from 6 to 12 months. The project will be financed under CPE. Allocation of Funds will depend on the research area, number of proposals and availability of funds.

- **NATURE OF ASSISTANCE:**

The quantum of assistance for a research project will be as under:

1. Minor Research Project in Humanities, Social Science, Languages, Literature, Arts, Law and allied disciplines - upto Rs. 3.00 lacs.
2. CSS project in Humanities, Social Science, Languages, Literature, Arts, Law and allied disciplines - upto Rs. 1.50 lacs.

- **Non-Recurring Grants**

a. Equipment (Minor equipment only)

b. Books and Journals

The equipment as well as books & journals grants may be utilized to procure the essential equipments and books & journals needed for the proposed research work.

The equipments and books & journals acquired by the Principal Investigator under a Minor Research Project must be deposited to College or in the departmental library or the central library after the completion of the project which will be the institutional property.

- **Recurring Grant**

(a) Hiring Services

This is meant for specialized technical work, such as sample analysis, for which the Institution either has no infrastructure or such services are available on payment basis.

(b) Contingency

The admissible contingency grant may be utilized on spares for apparatus, photo-stat copies and microfilms, typing, stationary, postage, telephone calls, internet, fax, computation and printing needed for the project. Expenditure towards the audit fee may also be claimed under contingency head.

(c) Special Needs:

Assistance may be provided for any other special requirement in connection with the project which is not covered under any other 'Head' of assistance under the scheme.

(d) Travel and Field Work

The amount allocated under the head travel/field work is to be utilized for data collection and collection of other information such as documents and visit to libraries within the general scope and sphere of the ongoing project. This should not be used for attending conferences, seminars, workshops and training courses etc. They may also avail special casual leave/duty leave for field work/collection of data as per University rules.

(e) Re-Appropriation

The Principal Investigator may re-appropriate maximum 20 per cent of the recurring grant allocated under each head with the permission of Principal under intimation to the Research committee with the justifications.

- **Tenure and Implementation**

1. Two years (in case of MRP) one year (in case of CSS project)
2. The effective date of implementation of the project will be mentioned in approval-cum sanction letter.

- **PROCEDURE FOR APPLYING**

All eligible teachers should submit their Research Proposals applications & CSS application from 1st March to 31st March of the current academic year in the prescribed proforma to be undertaken in the next academic year.

- **PROCEDURE FOR APPROVAL**

The received proposals will be duly assessed with the help of Research and Review Committee (RRC) constituted by the college. The final decision will be taken on the basis of recommendations made by the Committee and the availability of funds under the scheme.

- **PROCEDURE FOR RELEASE OF GRANTS**

The first installment of the grant shall comprise of 100% of the Non – Recurring and 50% of the total Recurring grant approved by the college for the total duration of the project. The grant will be released to the principal investigator. On receipt of Six Monthly Progress Report for MRP and Quarterly for CSS, statement of expenditure and utilization certificate of 1st instalment of grant, the 40% of the total recurring grant will be released as second installment after submission Six Monthly / Quarterly reports. Remaining 10% will be released on receipt of following completion documents as final reimbursement:

1. Copy of the final report of project along with soft copy.
2. Copy of the published article in UGC approved journal (in case of pending publication- an acceptance letter from the editor of the said journal)
3. A consolidated item wise detailed statement of expenditure incurred during the complete project period in the prescribed proforma duly signed and sealed by the Principal and the Principal Investigator
4. A consolidated Audited Utilization Certificate for the amount actually utilized towards the project duly signed and sealed by Govt. Internal Auditor/ Chartered Accountant, Principal as well as the Principal Investigator in the prescribed proforma.
5. The unutilized grant if any, may be refunded immediately through demand draft drawn in favour of the Principal, Symbiosis College of Arts & Commerce.

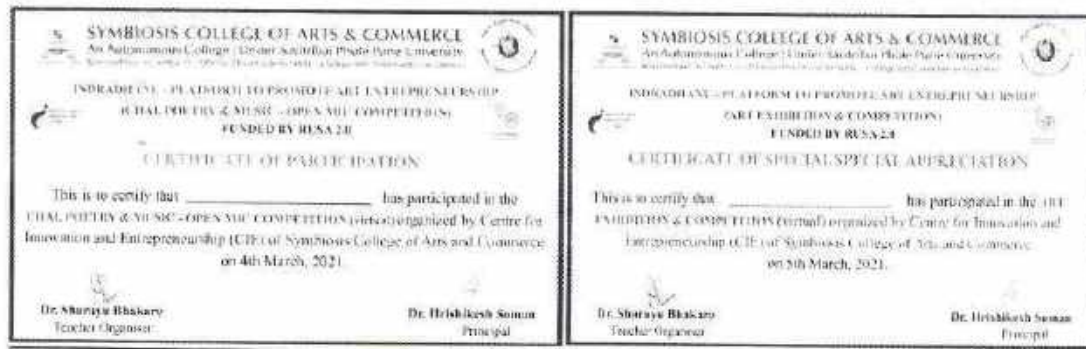

The answer to this was in the innovation he built named Shuddham, this low-cost water filter can filter 90,000 liters of water in six months and uses no electricity. He has been the recipient of a plethora of awards including the likes of Karnaveer Chakra, Youngest Scientist Award, and Ekalavya Chakra. He is also a research fellow at IIT Kanpur.

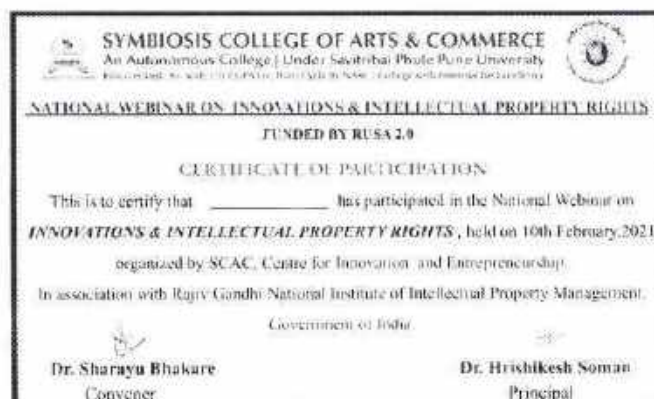

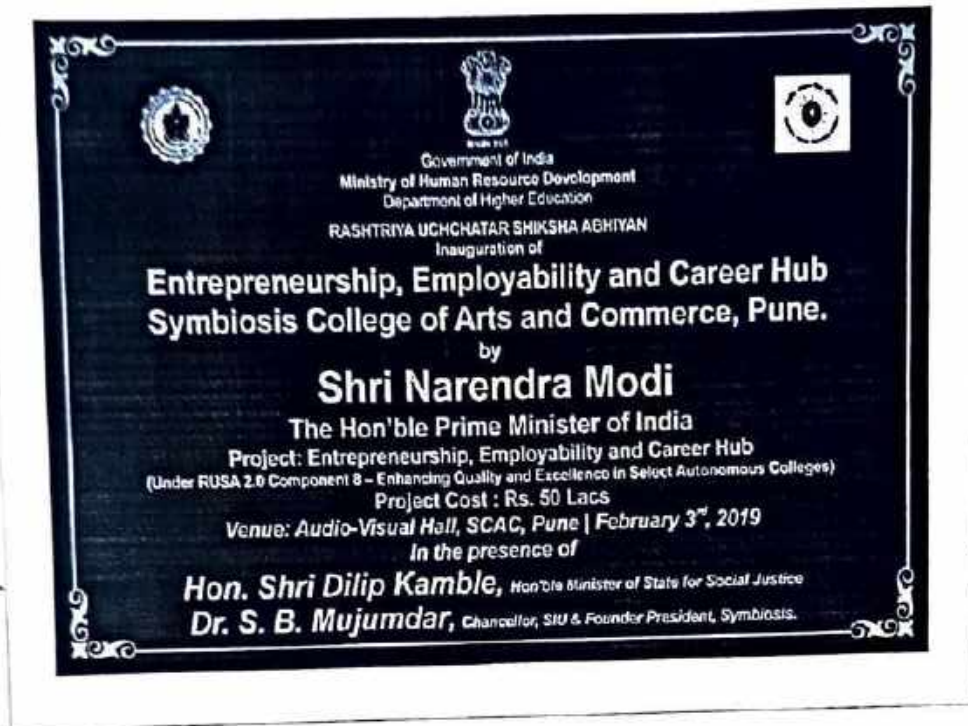

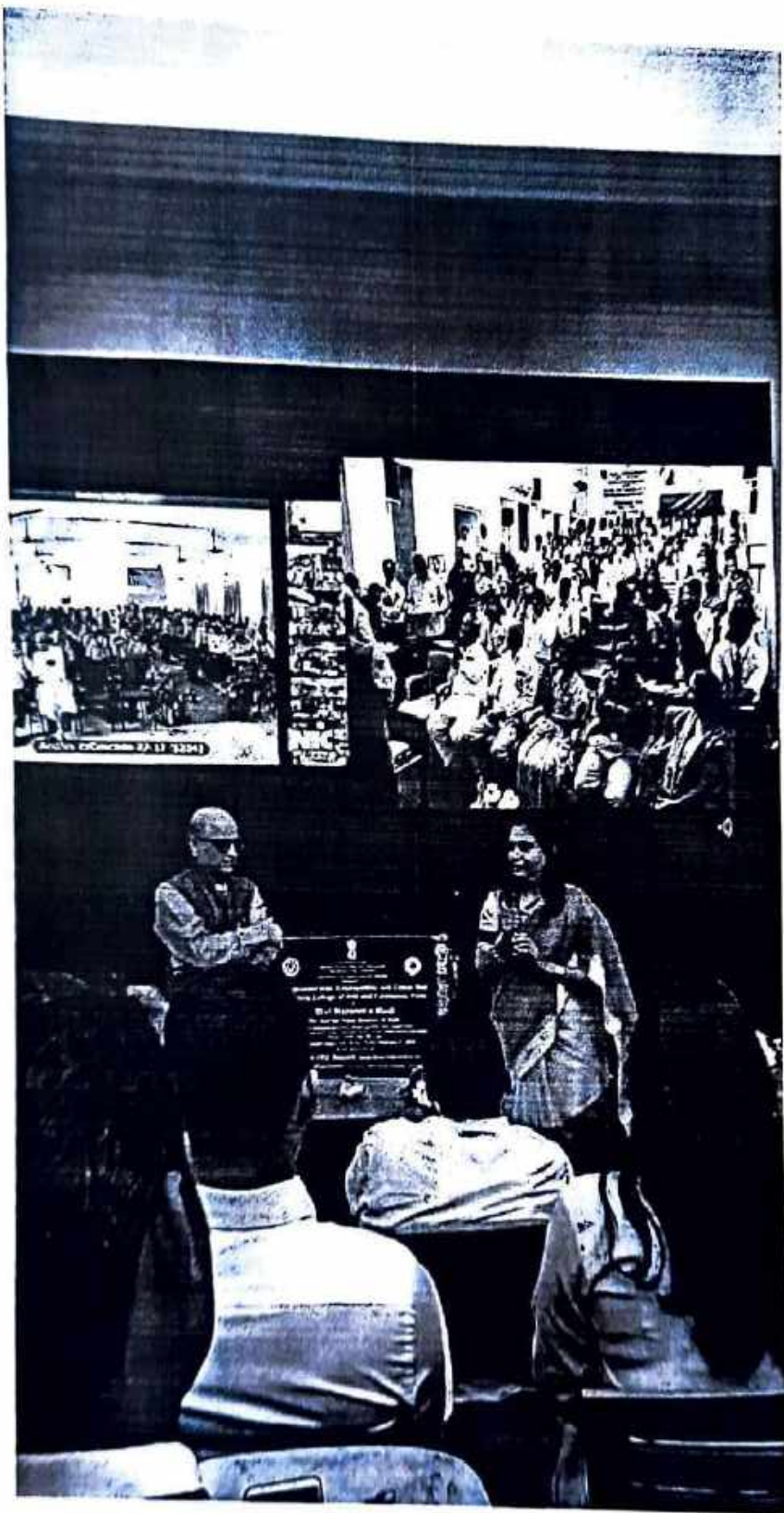
